NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being approximately 6 miles West of the City of Greenville, in Paris Mountain Township, County of Greenville, State of South Carolina, on Saluda River containing 2.03 acres, more or less, and being a portion of the old Hattie Cunningham Farm and being described according to a survey made by Dalton & Neves, Engineers, dated July, 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book HH at page 163, the aforementioned premises having according to said plat the following metes and bounds:
