NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All markertain piece/parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Sylvan Drive, in the City of Greenville, being shown as lots #53, 54, and 55 on plat of Country Club Estates, made by Dalton & Neves, October, 1926, recorded in the R.M.C. Office for Greenville County in Plat Book G at Pages 190 and 191, and having according to said plat and a survey made by R. E. Dalton, November 25, 1946, the following metes and bounds. to-wit:

"BEGINNING at an iron pin on the North side of Sylvan Drive, at joint front corner of lots # 55 and 56, and said pin also being 472 feet West from the Northwest corner of the intersection of Sylvan Drive and Ridge Drive, and running thence with line of lot # 56, N. 23-22 W. 170 feet to an iron pin; thence along the rear line of lots # 36, 37, 38, S. 72-20 W. 150.9 feet to an iron pin; thence with line of lot # 52, S. 23-22 E. 135.7 feet to an iron pin on the North side of Sylvan Drive; thence with the North side of Sylvan Drive, N. 78-38 E. 51 feet to an iron pin; thence along the North side of Sylvan Drive, N. 87-43 E. 107.7 feet to the beginning corner."

Being the same premises conveyed to the mortgagors by two deeds recorded in Volume 303 at Page 241, and Book of Deeds 419 at Page 222.
