All that certain piece, parcel or tract of land, with the buildings and improvements thereon, situate, lying and being on the Northwest side of the Greenville-Spartanburg Super Highway (also known as U.S. Highway 29), near the City of Greenville, in Chick Springs Township, Greenville County, South Carolina, containing ten (10) acres, according to survey made by Dalton & Neves, Engineers, August 1941, and having, according to said plat, the following metes and bounds, to-wit:
