

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Five Thousand. Five Hundred and No/100 - - - - -

(\$5,500.00.—) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

NOW KNOW ALL MEN, That I/we, the said mortgagor (s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor (s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville on the Northwest side of Simmons Avenue near the Laurens Road, known and designated as Lot No. 198 on plat of East Lynne Addition made by Dalton & Neves, Engineers, May, 1933, and having, according to said plat which is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book H, at Page 220, the following metes and bounds, towit:

"BEGINNING at an iron pin on the northwest side of Simmons Avenue, joint corner of Lots Nos. 197 and 198, and running thence with the line of Lot No. 197, N. 42-30 W. 222 feet to an iron pin; thence S. 36-43 W. 50.9 feet to an iron pin, joint rear corner of Lots Nos. 198 and 199; thence with the line of Lot No. 199, S. 42-30 E. 212.5 feet to an iron pin on the northwestern side of Simmons Avenue; thence with said Simmons Avenue, N. 47-30 E. 50 feet to the point of beginning; being the same conveyed to me by Mary M. Brown by deed dated February 6, 1956, not yet recorded."
