NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Circle Street and the Eastern side of Lindbergh Street in the Slater Manufacturing Company Village at Slater, and known and designated as Lot No. 5, of Block F, as shown on plat entitled "Plat Showing Revisions of Property of Slater Manufacturing Co., Slater, South Carolina," made by Pickell & Pickell, Engineers, Greenville, S. C., July 31, 1951, revised August 23, 1951, and recorded in the R. M. C. Office for Greenville County in Plat Book AA, at page 121, and having, according to said plat, the following metes and bounds:

"BEGINNING at an iron pin on the Northeastern side of Circle Street at the joint front corner of Lots 4 and 5, of Block F, and running thence along the Northeastern side of Circle Street, N. 17-53 W. 87 feet to an iron pin on the Eastern side of Lindbergh St.; thence with the Eastern side of Lindbergh Street, N. 24-42 E. 28 feet to an iron pin; thence N. 81-26 E. 126.2 feet to an iron pin on the Southwestern side of an unnamed street; thence along the Southwestern side of said unnamed street, S. 10-50 E. 84 feet to an iron pin at the joint rear corner of Lots 4 and 5, Block F; thence along the common line of said two lots, S. 70-70 W. 133.3 feet to an iron pin, the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty."
