SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgager(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Twenty-One Thousand, Four Hundred and No/100 - - -

(\$21,400.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, School Dist. 271, being known and designated as Lot No. 33 of a subdivision known as Liberty Park as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 145, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Proffitt Drive, joint front corner of Lots Nos. 32 and 33, and running thence with the joint line of said lots, S. 81-00 W. 167.5 feet to an iron pin at the rear corner of Lot No. 25; thence with the rear line of Lot No. 25, N. 6-00 W. 120.6 feet to an iron pin, joint rear corner Lots Nos. 33 and 34; thence with the joint line of said lots, N. 83-03 E. 154.7 feet to an iron pin on the western side of Proffitt Drive; thence with said drive, S. 12-03 E. 115 feet to the beginning corner; being a portion of the property conveyed to me by J. H. Sitten, et al. by deed dated December 1, 1955 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 540, at Page 161."
