WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and No/100 - - - -

DOLLARS (\$6000.00 ), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Davidson Road, Paris Mountain Township, containing 7.6 acres and having according to plat recorded in Plat Book "JJ" at Page 28, the following metes and bounds, to-wit:

"BEGINNING at an iron pin in the center of Davidson Road at the joint corner of property heretofore conveyed to J. C. Looper and running thence with the center of Davidson Road as the line N. 85-52 E. 158.8 feet to an iron pin; thence S. 57-45 E. 585.6 feet to pin; thence down the meanders of branch as the line, the chords of which are: S. 48-30 W. 156 feet; S. 21-30 W. 213 feet; S. 18-30 E. 140; S. 18-57 W. 132.5 feet; thence N. 63-06 W. 598.3 feet to pin at corner of Looper tract; thence with the rear line of the Looper tract S. 85-52 W. to pin at corner of new road; thence with the center of said road N. 9-19 W. 585.8 feet to pin in center of Davidson Road, being the point of beginning."

Said premises being the major portion of property conveyed to the mortgagor by deed recorded in Deed Book 429 at Page 173.
