NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Green and Chick Springs Township, located on the West side of South Main Street and having the following courses and distances: BEGINNING at an iron pin on the West side of South Main Street at the corner of the A.R. Wood property, and runs thence S. 77 W. 208.5 feet along the line of the Wood property to a stake; thence S. 5 W. 208.5 feet along line of Lot No. 1 to a stake on Buncombe Street; thence with Buncombe Street N. 76.45 E. 208.5 feet to an iron pin at intersection with South Main Street; thence with South Main Street; thence with South Main Street; thence with South Main Street N. 5 E. 208.5 feet to the beginning corner, and being all of that property conveyed to the mortgagor by E.
