MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Seven Thousand, One Hundred and No/100-----

(\$ 7,100,00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, being known and designated as an unnumbered lot near the intersection of Lake Shore Drive and Maple Drive and having, according to a Plat of two lots prepared for Hoyt Walters by Terry T. Dill, Reg. C.E. & L.S. dated January 21, 1956, the following metes and bounds to wit:

"BEGINNING at an iron pin on the Eastern side of Maple Drive near the intersection of Maple Drive and Lake Shore Drive, and running thence N. 59-53 E 90 feet to an iron pin on the Northwestern side of Lake Shore Drive; thence with said Drive, N 23-20 E 97.3 feet to an iron pin at the corner of a lot now or formerly owned by Hoyt Walters, thence with said lot N. 32-52 W 140 feet to an iron pin along the Southeastern side of a Subdivision; thence with said Subdivision, S. 60-38 W 160 feet to an iron pin on the Northeastern side of Maple Drive; thence with said Drive, S 30-07 E 200 feet to the beginning corner; and being a portion of the same property conveyed to Hoyt Walters by A. L. Henderson, by deed dated May 17, 1954 and recorded in the R. M. C. Office for Greenville County, in deed volume 499, at page 523."

The last payment on this mortgage, if not sooner paid, will become due and payable 20 years after date.
