E. Bannister, recently prepared by W. P. Morrow, Surveyor, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeastern side of Joan Street, the joint front corner of Lots 18 and 19, and running thence along the joint line of said lots, N. 83-06 E. 409.2 feet to an iron pin on the line of Sloan property; thence along the line of Sloan property, N. 4-00 E. 140 feet to an iron pin at the rear corner of Lot No. 17; thence along the line of that lot, S. 83-06 W. 411 feet to an iron pin on the southeastern side of a 30-foot unnamed street; thence along the southeastern side of a 30-foot unnamed street, S. 45-40 W. 54 feet to an iron pin at the intersection of said unnamed street and Joan Street; thence along the northeastern side of Joan Street, S. 17-10 E. 106.3 feet to the beginning corner; being a portion of the property conveyed to me by Garold D.
