## 28 Exhibit Schidtle A

The following described lots, pieces or parcels of land acquired by the Company since the execution and delivery of the Second Supplemental Indenture, or not described in the Original Indenture or in the Second Supplemental Indenture, located in the States and in the Counties designated and hereinafter set forth:

(1) All that certain small lot or parcel of land situate on the West side of Caughlin Avenue in the block between East River Street and Elizabeth Street in the City of Anderson, Anderson County, South Carolina, particularly shown on a plat prepared by Robinson Engineering Service, dated June 19, 1954. This lot is the Southeast corner of Lot No. 13 as shown on a plat by John V. Stribling dated May 20, 1905, and recorded in the Office of the Clerk of Court for said County in Deed Book Z-3, at Page 258. Said lot was conveyed to the late J. F. Watson by rised of A. W. Shaffer on May 31, 1905, recorded in said office in Deed Book G-4, at Page 84, and was inherited by the grantors from the said J. F. Watson.

Being the same premises conveyed to the Company by Mrs. Harriet Watson Sword, et. al., by deed dated July 23, 1954, and recorded on July 30, 1954, in Book 9-X at Page 90. Together with the rights, privileges and easements, if any, and subject to the exceptions and reservations of record affecting said premises.

(2) A certain tract or parcel of land in Graham Township, Alamater County, North Carolina, adjoining the lands of Daniel H. Langley, mahlie mad, Mrs. George N. Moser, and being more particularly described as follows:

Business at an iron pin in the Western margin of a 30 ft. public road (waid road running generally North and South between N. C. Highway No. 54 and the Hanford Brick Yard Road, formerly Holt Road), a corner with Mrs. George N. Moser and running thence with the Western margin of said road N. 41 deg. 50' E. 75 ft. (Langley deed N. 43 deg. 45' E.) to an iron pin, a new corner with Langley and in the Western margin of the above mentioned road; thence a new line with Langley N. 43 deg. 40' W. 200 ft. to an iron pin, a corner with Langley; thence again with Langley S. 41 deg. 50' W. 75 ft. to an iron pin, a new corner with Langley and in the line of Mrs. George N. Moser; thence with the line of Mrs. George N. Moser S. 43 deg. 40' E.

(Langley deed S. 41 deg. 45' E.) 200 ft. to the beginning, the same being a portion of land from the Southern or rear end of the property owned by the grantors which was deeded to them by A. P. Being the same premises conveyed to the Company by Daniel H. Langley and wife by deed dated January 12, 1953, and recorded on January 14, 1953 in Book 214 at page 221. Together with the rights, privileges and easements, if any, and subject to the exceptions and reservations of record affecting said premises.

(3) All that certain lot or parcel of land, situate, lying and being in Charlotte Township, Mecklenburg County, State of North Carolina, and more particularly described and defined as follows:

Beginning at a stake on the extension of South Tryon Street (Camden Road), which stake is 366 feet and 8 inches, from the north corner of the lot of land known as the E. B. Springs Land, which was conveyed to the said E. B. Springs by E. T. Cansler, Commissioner by deed duly registered in Book 83, page 34, to which reference is made. The said stake being three hundred and sixty-six ft. and eight inches south from the intersection of Rigler Street with the said South Tryon Street or Camden Road, and runs with the line of South Tryon Street extended in a southerly direction 33 feet and 4 inches to a stake; thence back toward the C. C. & A. Railroad 150 feet to a stake in the line of South College Street, extended; thence parallel with the line of South Tryon Street, extended, and toward Rigler Street 33 feet and 4 inches to a stake; thence in a westerly direction 150 feet to the BEGINNING.
