I, M. W. Massey (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Four Thousand Five Hundred and No/100 -

with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, near the Franklin Road, being known and designated as Lot No. 6 on Plat of property of G. C. Chastain recorded in the R.M.C. Office for Greenville County in Plat Book AA, at page 175, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of an unnamed Street leading off the Franklin Road, at the joint front corner of Lots Nos. 5 and 6, and running thence with the line of Lot No. 5, S. 84-30 E. 312.5 feet to an iron pin; thence S. 2-34 E. 62 feet to an iron pin at the mear corner of Lot No. 7; thence with the line of Lot No. 7, N. 86-57 W. 322.4 feet to an iron pin on unnamed street; thence with the Eastern side of said unnamed Street, N. 6-75 E. 75 mes to the beginning.
