State, at Chambers or otherwise, for the appointment of a Becsiver, with authority to take charge of the mortgaged premises, designate a ressonable rettal and collect same and apply the net proceeds thereof (after paying cost of collection) upon said debt, interest, takes and fire insurance, without liability to account for anything more than the rents and profits actually collected.

In the event forclosure of the premises hardinabove described is instituted the mortgagor(s) herein expressly waives (or waive) the benefit of any and all appraisament laws under the Statutes of the State of South Carolina.
