All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, located just North of Piedmont, S. C. on East Side of State Highway #29. This being a portion of the plat recorded in the Office of R.M.C. for Greenville County in Plat Book, Volume R, Page 53, and known as Lot #13 and a portion of Lot #12, and having the following dimensions to wit;
