Greenville Township, Greenville County, State of South Carolina. on the northern side of Pine Forest Drive in the City of Greenville, being lots 39 and a portion of 38, 40 and 41 of Block B, as shown on Plat of Forest Hills, recorded in Plat Book "D", at page 206, and having according to a revised plat made by R. E. Dalton in December 1941, recorded in Plat Book "O", at page 69, the following metes and bounds to wit:

BEGINNING at an iron pin on the northern side of Pine Forest Drive, corner of lots 38 and 39 and running thence with the property of Marie D.
