with interest from date at the rate of five (5%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Claude McCombs

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

First National Bank, Greenville, S.C., its successors and assigns:

All that certain lot of land, with the improvements thereon, situate in the County of Greenville, State of South Carolina, Chick Springs Township, containing one acre more or less, being formerly situate on the northern side of Piney Mountain Road, and now situate on the northern side of S.C. Highway By-Pass 291, and having the metes and bounds as follows, as set forth in the original deed:

Beginning at a point on the northern side of Piney Mountain Road, at the corner of property now or formerly of Loure Murrary, and running thence along the Murrary property, N 15-15 W 192.5 feet to an iron pin at the rear corner of the Murrary property, thence N 87-05 W 187 feet to the corner of property now or formerly of Cornelia Holmes, thence with the Holmes property S 15-15 E 243 feet to an iron pin on said Piney Mountain Road, thence with said road N 81-27 E 96 feet to a bend, thence N 69-25 E 83 feet to the point of beginning, and being the same property conveyed to me by H.K.
