(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-three Hundred and No/100

DOLLARS (\$ 2300.00

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: PAYABLE: \$30.23 on the 27th day of October, 1956, and a like payment of \$30.23 on the 27th day of each month thereafter, to be applied first to interest balance to prindpal, until paid in full, with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed and aid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeast side of Virnelle Street, in the City of Greenville, being shown as Lot No. 6, on a plat of property of Central Realty Corporation, recorded in Plat Book Q at Page 35, and described as follows:

\*BEGINNING at a stake on the southeastern side of Virnelle Street 81 feet southwest from Medleck Drive, and running thence S. 36-05 E. 174.5 feet to a stake; thence S. 54-03 W. 61 feet to a stake at corner of Lot No. 5; thence with the line of Lot No. 5 N. 36-05 W. 174.5 feet to a stake on Virnelle Street; thence with the southeast side of said Street N. 54-03 E. 61 feet to the beginning corner."
