All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, county of Greenville, Chick Springs Township, in the City of Green, located on the east side of Lan-ford Street, known and designated as Lot No. 14 on a plat of property known as Westmoreland Circle, whick plat is recorded in the R.M.C. Office for Greenville County in Plat Book H, at page 143, and having the following courses and distances:

BEGINNING at an iron pin on the east side of Lanford Street, joint corner of Lots Nos. 13 and 14, and runs thence S. 72.20 E. 150 feet to an iron pin; thence N. 17.40 E. 60 feet to an iron pin; thence N. 72.20 W. 150 feet to an iron pin on the east side of Lanford Street; thence therewith S. 17.40 W. 60 feet to the beginning corner, and being all of that lot of land conveyed to the mortgagor by H.S.
