(\$ 13.000.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of \_One\_Hundred\_\_\_\_

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in the said truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Arbutus Trail and being known and designated as Lot No. 36 of Elletson Acres as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book "EE", Page 161 and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Arbutus Trail at the joint front corner of Lots Nos. 36 and 37 and running thence along the joint rear line of said lots N. 87-29 W. 183 feet to a point in the center of a creek; thence down the meanders of said creek as the line (the chord of which is S. 4-05 E.) 105.5 feet to a point in the creek at the joint rear corner of Lots Nos. 35 and 36; thence along the joint line of said lots N. 88-21 E. 161.0 feet to an iron pin on the western side of Arbutus Trail, joint front corner of Lots Nos. 35 and 36; thence along the western side of Arbutus Trail N. 1-39 W. 44.7 feet to an iron pin; thence still along the western side of Arbutus Trail N. 6-46 E. 45.3 feet to the beginning corner. Being the same property conveyed to me by Analane C. Gibson by deed of even date not yet recorded."
