) Dollars the first installment of said principal being due and payable on the First day of November and thereafter the remaining installments of principal , 1957 being due and payable annually until the entire principal sum and interest are paid in full, and each installment of principal and interest bearing interest from due date until paid at the highest rate authorized to be charged under the Federal Farm Loan Act, as amended; all of which and such other terms, conditions and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW, KNOW ALL MEN, that first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell, and release, in fee simple, unto second party, its successors and assigns, the following described lands, to wit:

All that piece, parcel or tract of land lying and being in Saluda Township, Greenville County, South Carolina, on the eastern side of the North Saluda River and being in Tax District No. 470, containing twenty-two and one-quarter (22-1/4) acres, more or less, according to survey and plat made by W. A. Hester, Surveyor, on January 15, 1923, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book LL , page 145 , which plat and the record thereof are by reference incorporated herein. According to that plat it is bounded on the north by the North Saluda River and a creek; on the east by a branch with Batson's land lying to the east thereof; on the south by lands now or formerly of Chas. Hodges; and on the west by the North Saluda River. It is the same tract of land conveyed to Bessie Mae Howard by Mrs. L. C.
