(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the east side of South Trade Street in the City of Green, being Lots Nos. 1 and 2 of the W.A. Rogers Estate according to survey and plat by R.W. Datton, dated March 1924, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on east side of South Trade Street, corner of Lot No. 3, and running thence with the line of said lot, N. 89.08 E. 183.6 feet to an iron pin; thence S. 17.48 E. 100 feet to a pipe; thence S. 88.51 W. 187 feet to an iron pin on east side of said street; thence with the Street, N. 15.48 W. 100 feet to the beginning corner.
