All that certain lot of land situated in Chicks Spaings Township County and State aforesaid, being known and designated as Lots Nos. 2 and 3 in what is known as Woodland Heights, property of the I.M. Wood Estate as shown on a subdivision and plat of same made by H.S. Brockman, Reg. Surveyor, dated October 28, 1955, said plat being of record in the R.M.C. Office for Greenville County in Plat Book GG, page 151 and having the following metes and bounds and courses and distances as shown by said plat, to wit:

BECENNING at an iron pin in line of State Highway No. 14, joint front corner of Lots 3 and 4, and running thence N. 49-18 E. 200 feet to an iron pin at the joint rear corner of lots 3,4, 35 and 36; thence N. 39-15 W. 190 feet to an iron pin in line of Bessie Avenue; thence along the line of said Avenue S. 45-18 W. 200 feet to an iron pin at the corner of said Avenue and State Highway No. 14; thence along the line of said Highway S. 39-15 E. 190 feet to the beginning point.
