NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 7 as shown on a plat of Sevier Court, prepared by C. C. Jones & Associates, dated February 29, 1956, and recorded in the R.M.C. Office for Greenville County in Plat Book EE at page 180, and having according to said plat the following metes and bounds::

BEGINNING at an iron pin on the Southern side of Sevier Court at the joint front corner of Lots Nos. 6 and 7, and running thence with the line of Lot No. 6 S. 1-50 W. 109.9 feet to an iron pin in the line of property now or formerly of Osborne; thence with the line of property now or formerly of Osborne N. 88-10 W. 65 feet to an iron pin at the joint rear corner of Lots Nos. 7 and 8; thence with the line of Lot No. 8 N. 1-50 E. 125 feet to an iron pin on the Southern side of Sevier Court; thence with the Southern side of Sevier Court S. 88-10 E. 19.3 feet to an iron pin; thence continuing with the curve of the Southern side of Sevier Court, the chord of which is S. 69-47 E. 48 feet, to the point of beginning.

This is the identical property conveyed to the mortgagor herein by Leslie & Shaw, Inc. by deed dated December , 1956, and to be recorded herewith in the R.M.C. Office for Greenville County, S.C.

In the event Sevier Court is extended and the turn-around as shown on said plat is eliminated, that part of the turn-around abutting on said Lot 7, which shall have been eliminated so that said Lot 7 borders on Sevier Court as so relocated, shall be included under the terms of this mortgage.
