All that certain piece, parcel or let of land in Greenville County, State of South Carolina, on the Northeastern corner of Florida Avenue and Texas Avenue, near the City of Greenville, being shown as lot #191 of Section 2 on a plat of Oak Crest, recorded in the R.M.C. Office for Greenville County in Plat Book GG at Page 131, and according to a survey prepared by R. E. Dalton in February 1957 is described as follows:
