"BEGINNING at an iron pin on the northwestern side of Cammer Avenue at a point 30 feet southwest of the joint corner of Lots Nos. 16 and 17, and running thence along the line of said Cammer Avenue, S. 42-10 W. 90 feet to an iron pin at the joint corner of Lots Nos. 18 and 19; thence along the joint line of said lots, N. 47-50 W. 166.35 feet to an iron pin at the joint rear corner of Lots Nos. 18 and 19; N. 42-10 E. 90 feet to an iron pin in the rear line of Lot No. 17, which point is 30 feet southwest of the joint rear corner of Lots Nos. 16 and 17; thence on a line through the center of Lot No. 17, S. 47-50 E. 166.4 feet to the beginning corner; being the same conveyed to us by J. L. Armstrong, et al. by deed dated September 17, 1945 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 280, at Page 263.
