"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in the City of Greenville, on the southern side of Brookwood Drive, being known and designated as the northern portion of Lot No. 45, as shown on a revised plat of Park Hill prepared by Dalton & Neves, Engineers, May, 1940, recorded in the R. M. C. Office for Greenville County in Plat Book J at Page 208, and being more particularly described according to said plat, as follows:

Lewis by deed dated December 10, 1947, recorded in Volume 330 at Page 486; Mary Harrill Martin having conveyed an artificial one-half interest in and to said property to the mortgagor by deed recorded in Deed Book 347 at Page 475 on May 25, 1948.
