NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successsors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lots # 1 and 2 on a plat of East Lynn, recorded in the R.M.C. Office for Greenville County in Plat Book H at Page 195, and lot #4 on plat of property of Edgar West, recorded in the R.M.C. Office for Greenville County in Plat Book L at Page 165, and having according to said plat the following metes and bounds,

"BEGINNING at an iron pin on the Northeast side of Laurens Road, at joint front corner of lots # 2 and 3, of East Lynne, said pin being 150 feet in a northwesterly direction from the point where the Northeast side of Laurens Road intersects with Northwest side of Lindsay Avenue, and running thence along the Northeast side of Laurens Road, N. 55-45 W. 117.5 feet to iron pin; thence N. 33-46 E. 149.8 feet to iron pin; thence N. 12 E. 54.5 feet to pin; thence S. 55-45 E. 142 feet to pin; thence S. 35-06 W. 200 feet to pin on Laurens Road, the point of beginning."
