ALL those lots of land with the buildings and improvements thereon situate on the Northwest side of Sunset Drive in the City of Greenville, in Greenville County, South Carolina, being shown as Lots 90 and 91, on plat No. 2, of Sunset Hills, made by R. E. Dalton, C.E. Dec. 1945, recorded in the RMC Office for Greenville County, S. C., in Plat Book "P", page 19, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Sunset Drive at joint front corner of Lots 89 and 90, and running thence with the line of Lot 89, N. 47-03 W., 239.8 feet to an iron pin; thence N. 66-0 E., 33.8 feet to an iron pin; thence N. 68-25 E., 180 feet to an iron pin on the Southwest side of Osceola Drive; thence along Osceola Drive, S. 28-32 E., 147.3 feet to an iron pin; thence with the curve of Osceola Drive and Sunset Drive (the chord being S. 28-34 W., 75 feet) to an iron pin on Sunset Drive; thence continuing with Sunset Drive, S. 50-09 W., 75 feet to the beginning corner.
