NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of

Greenville , State of South Carolina:

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, near the City of Greer, and south therefrom, known and designated as lot # 46, on a plat of the property known as Pleasant Heights, property of R. A. and I. B. Dobson, according to a survey and plat by H. L. Dunahoo, surveyor, recorded in Plat Book T at Pages 274-275, and according to a more recent survey prepared by H. S. Brockman is described as follows:

BEGINNING at an iron pin on the Northern side of Bailey Avenue, at the joint front corner of lots # 45 and 46; thence with the line of said lots, N. 3-45 E. 224 feet to an iron pin; thence with the line of lot # 37, S. 84-38 E. 100.2 feet to an iron pin; thence with the line of lot # 47, S. 3-54 W. 231.7 feet to an iron pin on Bailey Avenue; thence with said Avenue, N. 80-09 W. 99.8 feet to the point of beginning.
