All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Butler Township, Greenville County, State of South Carolina, situate, lying and being on the Northern side of Sycamore Drive, and being known and designated as Lots Nos. 67 and 68 of East Lynne as shown on Plat thereof by Dalton & Neves, Engineers, dated June, 1931, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book "H", at page 195, and being described together according to said plat as follows:

BEGINNING at an iron pin on the Northern side of Sycamore Drive, joint front corner of Lots Nos. 68 and 69, and running thence N. 9-14 W. 175.7 feet to an iron pin, joint corner of Lots Nos. 40, 41, 68 and 69; thence N. 81-02 E. 50 feet to an iron pin, joint corner of Lots Nos. 42, 43, 66 and 67; thence S. 19-14 E. 183.7 feet to an iron pin on the Northern side of Sycamore Drive; thence along Sycamore Drive, N. 89-46 W. 50.7 feet to the beginning corner.
