TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Frances Hall Smith (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 765.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in the City of Greenville, on the Southern side of Ackley Road, being shown and designated as lot # 4 on plat of William Hall Estate, and also being shown as lot # 2.4, Block 7, Page 200 of the County Block Book, and being more particularly described as follows:

BEGINNING at a point on the Eastern side of Nicholtown Road, at the corner of property now or formerly owned by Sylvia Foster, and running thence N. 80-04 E. 162.1 feet along the line of Foster property; thence S. 6-27 E. 66.6 feet along line of lot # 2, of Hall property; thence S. 70-45 W. 22.8 feet to pin; thence S. 80-04 W. 146 feet to point on Nicholtown Road; thence N. 1-31 W. 71 feet along the Eastern side of Nicholtown Road to the beginning corner."

Said premises being the same conveyed to the mortgagor by deed recorded in Deed Book 486 at Page 124.
