M. C. Office for Greenville County in Plat Book KK, Page 105, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Broadmoor Drive, joint front corner of Lots Nos. 46 and 47 and running thence with the joint line of said lots N. 74-38 E. 164.6 feet to an iron pin in the rear line of Lot 49; thence with the rear line of Lot No. 49 N. 17-24 W. 54.4 feet to an iron pin in the joint rear corner of Lots Nos. 48 and 49; thence with the joint line of Lots Nos. 47 and 48 N. 21-06 W. 125 feet to an iron pin on the south side of Indian Springs Drive; thence with said Drive S. 61-21 W. 80 feet to a point; thence continuing with said Drive S. 55-00W. 75 feet to a point; thence continuing with Indian Springs Drive as it intersects with Broadmoor Drive following the curvature thereof, the chord of which is S. 46-15 W. 43.2 feet to a point on the eastern side of Broadmoor Drive; thence with said Orive S. 37-29 E. 35 feet to a point; thence continuing with said Drive S. 17-20 E. 65 feet to the beginning corner.
