"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Tindal Avenue, in the City of Greenville, being shown as lot #31 of Block B on plat of Cagle Park, recorded in Plat Book C at Page 238, and described as follows:
