per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, lying on the south side of Green, to Locust Road (S.C. Highway No. 415) and bounded by lands of C.S. Tate, J.C. Bradley, lands of Ann Trammel and State Highway No. 415, and containing Four (4) acres, more or less, and having the following metes and bounds:

BEGINNING at an iron pin on Bank of highway at J.C. Bradley's line and running thence S. 41-00 W. 755 feet to iron pipe near spring branch; thence S. 67-35 E. 253.5 feet to iron pipe; thence N. 41-00 E. 699 feet to a stake on bank of highway; thence with the highway, N. 55-00 W. 240.3 feet to the beginning corner.

This tract is subject to a forty feet wide right-of-way for a Greenville County Road on and along the E.A. Forrester's line.

This is the same property conveyed to Boyd Lister by deed of Ann Trammel, to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
