NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, in or near the Town of Simpsonville, being known and designated as Lot No. 16 on plat of property of J. R. and G. R. Richardson. The plat is recorded in the Office of the R. M. C. for Greenville County, in Plat Book Q at page 159, and reference is made thereton for a more definite and particular description as to courses and distances and metes and bounds:

The lot begins on the North side of Perry Street which is unnamed on the plat at the corner of lat no. 17, and runs thence along the joint lines of lots numbers 16 and 17, N. 19-45 W. 258 feet to corner; thence N. 13-30 E. 47.2 feet to another corner; thence N. 70-30 W. 58.5 feet to corner on Lot No. 15 in the said subdivision; thence along joint lines of Lots Nos. 15 and 16, S. 19-45 E. 291.2 feet to corner on North side of Perry Street; thence along North side of Perry Street, S. 70-15 W. 90 feet to the beginning corner.
