on the Northern side of Waters Avenue, in the City of Greenville, being shown as Lot No. 4 on a Plat of Pickwick Heights recorded in Plat Book X, at page 141 and described as follows:

BEGINNING at a stake on the Northern side of Waters Avenue at the corner of Lot No. 3, and running thence with the line of said lot, N. 24-53 W. 132 feet to a stake; thence N. 65-07 E. 60 feet to a stake at corner of Lot No. 5; thence with line of said lot, S. 24-53 E. 132 feet to a stake on Waters Avenue; thence with the Northern side of Waters Avenue, S. 65-05 W. 60 feet to the beginning corner.
