

SEND GREETING:

Whereas, I, the said Milos Poole

Presents, am well and truly indebted to E. H. Edwards

in the full and just sum of Four Hundred Fifty Six and 57/100 (\$456.57)

Dollars , to be paid in monthly installments of Fifteen (\$15.00) Dollars per month, first payment due thirty days from date and like payments to continue each and everyy month thereafter until paid in full.

at the rate of 7 per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

E. H. Edwards, his heirs and assigns forever:

All that parcel, tract or lot of land, lying on northwest side of Piny Mountain road near its junction with McGee road, being in Chick Springs township, in Parker School District, County and State aforesaid, and having the following metes and bounds, to-wit:

BEGINWING at a sweet gum, thence N. $49\frac{1}{2}$ E. 1.09 chains; thence S. 42 E. 4.45 chains to iron pin on east side of Piny Mountain road; thence S. $34\frac{1}{2}$ W. 1.07 chains to iron pin on east side of Piny Mountain road; thence N. 42 W. 4.78 chains to the beginning corner, and containing one half $(\frac{1}{2})$ acre, more or less, according to survey made by J. Earle Freeman, September 3, 1940, and being the same tract of land conveyed to he by deed of J. P. Griffin and recorded in the R. M. C. Office for Greenville County, in Vol. 247, at page 30.
