NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in the City of Greenville, being known and designated as Lot No. 23 as shown on Plat of Northwood Subdivision recorded in Plat Book J, at pages 102 and 103, and being more particularly described according to a recent Survey prepared by C. O. Jones, Eng., March 20, 1954, as follows:

BEGINNING at an iron pin in the Northwest side of Mohawk Drive (formerly Chick Springs Road) at the joint front corner of Lots Nos. 23 and 24, and running thence with joint line of said lots, N. 30-06 W. 179 feet to iron pin; thence S. 9-16 W. 95 feet to iron pin, corner of Lot No. 22; thence with line of said lot, S. 31-00 E. 118.8 feet to iron pin in the Northwest side of Mohawk Drive; thence with said Drive, N. 47-35 E. 60 feet to the point of beginning.
