## **MORTGAGE**

Greenville, South Carolina , hereinafter called the Mortgagor, is indebted to Sumner G. Whittier , as Administrator of Veterans' Affairs, an Officer of the United States of America, and his successors in such office, as such, and his or their assigns, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of SEVEN THOUSAND ONE HUNDRED FIFTY AND NO/100-Dollars (\$ 7,150.00), with interest from date at the rate of Four & one-half per centum ( 23 %) per annum until paid, said principal and interest being payable at the office of the Loan Guaranty Officer, Veterans Administration Regional Office, at Columbia, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-Nine and 75/100- - -(\$ 39.75 day of March ), commencing on the 17th day of each month thereafter until the principal and interest and continuing on the 17th are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and day of Bobruary payable on the , 19  $\mathbf{g}_{\mathbf{3}}$  .

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, and unto his successors in such office, as such, and his or their assigns, the following described property, to-wit:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Greenville Township, on the eastern side of Nancy Drive (formerly Hampton Street) have the City of Greenville, being shown as Lot 27, on plat of property of Central Realty Corporation, recorded in Plat Book S at page 110, and being more particularly shown on a plat of the property of Homer Asby Gardner prepared by J. C. Hill, dated January 28, 1958, and according to said plat being more particularly described as follows:
