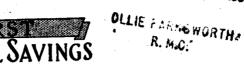

MORTGAGE OF REAL ESTATE

COUNTY OF GREENVILLE

To All Whom These Presents May Concern:

We, William Leslie Robbins, Boyce Robbins, Wilbur Robbins, and Jack G.

Robbins, d/b/a partners under the firm name of Robbins Brothers SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF

GREENVILLE, in the full and just sum of Seven Thousand, and No/100 - - - - - 7\$ 7,000.00)

Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Seventy and 80/100 - - - - - - - (\$70.80) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 11 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, a part thereof, if the same be placed in the hands of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt INGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents do grant, bar-whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, on the east side of the Augusta Road (U. S. Highway No. 25) about four miles south of Greenville Court House, being known and designated as the southwestern portion of Tract No. 7 of the property of Eva Chandler as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book H, at page 188, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a point in the center of the Augusta Road) U. S. Highway No. 25) at joint front corner of Lots Nos. 6 and 7, and running thence along the joint line of said lots, N. 89-00 E. 200 feet to an iron pin on the line of other property, now or formerly owned by Guy Robbins, Boyce Robbins, Wilbur Robbins, and Jack G. Robbins; thence along the line of other property, now or formerly owned by Guy Robbins, Boyce Robbins, Wilbur Robbins, and Jack G. Robbins, N. 1+00 W. 80 feet to an iron pin; thence S. 89-00 W. 200 feet to a point in the center of the Augusta Road (U. S. Highway 25); thence along the center of the Augusta Road, S. 1-00 E. 80 feet to the beginning corner; being a portion of the property conveyed to Guy Robbins, Boyce Robbins, Wilbur Robbins and Jack G. Robbins, by M. M. Stokely by deed dated July 24, 1947, and recorded in the R.M.C. Office for Greenville County in Vol. 316, at page 68. The said Guy Robbins died on October 15, 1956, leaving a will wherein he devised his interest in the above described property to his wife, Imogene G. Robbins. The said Imogene G. Robbins died on December 30, 1957, leaving a will, wherein she directed her Executor, Jack G. Robbins, to sell said interest to the Mortgagor, William Leslie Robbins, upon payment of a certain sum set forth in said will. The said Jack G. Robbins, as Executor, pursuant to the terms of said will, as of this date, executed a deed to the said William Leslie Robbins, and said deed being recorded herewith.
