SEND GREETING:

WHEREAS, A. B. Coleman & Lorena F. Coleman the said in and by our certain promissory note in writing of even date with these Presents, well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S.
