C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor... in hand well and truly paid by the said mortgagee, at and

before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, and being Lot #16 of Block B of sub-division known as Jefferson Heights, plat of which recorded in R. M. C. Office for Greenville County in plat Book C, pages 34 and 35. Said Lot having a frontage on Second Avenue of 25.5 feet and a depth along parallel line of 87.5 feet. This is the same lot of land conveyed to me by Ed Lewis by Deed recorded in Book 344, page 30 in the R. M. C. Office.

Also, all that other lot of land adjoining the above described lot and being known and designated as Lot #15 on above mentioned plat, and having the following courses and distances, to wit:-
