All that piece, parcel or lot of land in Oneal Township, Greenville County, State of South Carolina, lying on the West side of the Greer-Landrum Road, about two and one-half miles North from the Town of Greer, and being the Eastern portion of Lot NO. 6 as shown on a plat by H. S. Brockman, Surveyor, dated May 24, 1939, and having the following courses and distances, to wit:

Beginning at a point in the center of the said Greer-Landrum Highway, joint corner of Lots Nos. 5 and 6 on said plat, and running thence along the line of Lot No. 5, N. 87.30 W. 156.5 feet to a point; thence S. 2.30 W. 209.3 feet to a point on line of Lot No. 7; thence along the line of Lot No. 7, N. 88.40 E. 161 feet to a point in the center of the Greer-Landrum Highway; thence along the center of said Highway, N. 1.30 W. 65 feet to bend; thence N. 2.30 E. 135 feet to the beginning corner, containing seventy-four one hundredths (.74) of an acre, more or less.
