"All the certain piece sparce sor lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeastern side of Woodbriar Court, near the City of Greenville, being shown as Lots 28 and 29 on a plat of Woodbriar Court recorded in Plat Book KE at page 6, and described as follows:
