BEGINNING at an iron pin on the southeastern side of Lowndes Avenue at the joint front corner of Lots Nos. 18 and 19 and running thence along the joint line of said lots, S. 47-53 E. 180.2 feet to an iron pin on the line of Lot No. 20; thence along the line of that lot, N. 57-52 E. 51.9 feet to an iron pin on the line of the Vaughn Estate; thence along that line, N. 29-15 W. 80.6 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence along the joint line of said lots, N. 48-34 W. 131.2 feet to an iron pin on the southeastern side of Lowndes Avenue; thence along the southeastern side of Lownes Avenue, following the curvature thereof, the chord of which is S. 29-32 W. 58.5 feet to an iron pin; thence continuing along the southeastern side of Lowndes Avenue, S. 42-07 W. 21.5 feet to an iron pin the beginning corner; being the same property conveyed to me by Lucy F. Elletson, dated June 9th. 1958 and being recorded herewith ...
