IT IS FURTHER UNDERSTOOD AND AGREED between the parties hereto that except. as above modified, all of the provisions of said note and mortgage shall remain and be in full force and effect, according to their tenor, including all rights and remedies reserved to the Mortgagee to foreclose or otherwise proceed in the event of default on the part of the Mortgagor .
