near the City of Greenville, lying on the West side of Paris View Drive, being shown as Lot No. 42 on Plat of property of H. G. Stevens recorded in Plat Book M, at page 9, R.M.C. Office for Greenville County, and according to said Plat being more particularly described as follows:
