NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as Lots Nos. 12 and 13 of the property of Eliza T. Looper and according to plat made by R. E. Dalton, December, 1924, said lots lie on the east side of Washington Avenue and together have the following metes and bounds:

BEGINNING at the corner of Lot No. 11 on the east side of Washington Avenue exactly 232 feet north of the intersection of Washington Avenue and Gordon Street; thence along the east side of Washington Avenue N. 22 W. exactly 116 feet to the corner of Lot No. 14; thence with the line of Lot No. 14 N. 71-17 E. exactly 150 feet to the line of Lot No. 22; thence with the rear line of Lots Nos. 22, 21 and 20, S. 22 E. exactly 116 feet to the corner of Lot No. 11; thence with the line of Lot No. 11 S. 71-17 W. exactly 150 feet to the beginning corner.
