C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chicks Springs Township, about two miles south of Taylors, S. C., lying on the west side of the Berry Road, and being a part of the same land that was conveyed to Lucile Annie Kluge by deed from H. K. Kluge May 4th, 1953, recorded in the office of the R. M. C. for Greenville County in Deed Book 477 at page 374, and having the following courses and distances, to wit:-

BEGINNING on a nail and cap in the said Berry Road at S. 24-00 E. 25 feet from the corner in the said Berry Road, the same being the joint corner of the S. T.
