NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the east side of Carolina Avenue, near the City of Greenville, shown as Lot No. 4, Block J, Section 5, on plat of East Highlands Estates made by Dalton & Neves, Engineers, February 1941, and recorded in Plat Book K at Pages 78, 79 and 80, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on East side of Carolina Avenue at joint front corner of Lots Nos. 3 and 4 of Block J and running thence along the east side of Carolina Avenue S. 17-00 E. 70 feet to an iron pin joint front corner of Lots Nos. 4 and 5; thence with line of Lot No. 5 N. 77-45 E. 189.6 feet to an iron pin on west side of a 5 foot strip of land reserved for utilities; thence with the west side of strip of land reserved for utilities N. 00-24 W. 81 feet to an iron pin; thence with line of Lots 1 and 3 S. 75-03 W. 212.3 feet to an iron pin on the east side of Carolina Avenue, the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
